-This Co-operation Agreement will become effective as of the date of its last signature, and shall remain in force and effect for a term of one year, and shall be automatically renewed for additional terms of one year each unless terminated by either party with a written advance notice of three (3) months, it being understood that the expiration or termination of this Agreement shall not affect any internship program in course or already confirmed to the beneficiary/ies at the date of expiration or termination.

-This Co-operation Agreement is governed by its covenants and by the applicable laws and regulations in force in Italy, it being understood that this Agreement relates to "tirocini curricolari". The host organisation declares that it will abide to the applicable laws and regulations

-The host organization undertakes to provide the sending organization (also upon request of the latter) with periodic information concerning the performance of the internship program (s) of the beneficiary/ies.

At the completion of each internship program, the host organization shall provide the sending organization with a duly filled in final report, by using the form provided by the sending organization.
